



Deal value by region (\$bn)





Deal number by region




Top 10 Countries

Countries by deal value (\$bn)







Investment value by region (\$bn)





Number of investments by region





Acquisition value by region (\$bn)







Sectors by deal value (\$bn)











Sectors by deal value (\$bn)





Total deal value/population



Total deal value/population



Total deal value/internet user population




Country internet user statistics from Internet World Stats
